# WASTE WATER TREATMENT PLANT CONSTRUCTION UPDATE: SRI YAMANI

Sri Yamani from Wilson Engineers gave a presentation on the progress of the wastewater treatment plant. Yamani went over the project funding with costs of construction management, construction, and contingency. He discussed the funding sources, the timeline of the project with a final completion date of May 3, 2019, and issues faced thus far including higher ground water levels. Yamani also discussed the funding needed to complete the project and change orders. Yamani then answered questions from Council.

#### **CITY MANAGER REPORT**

- Soltis gave an update on the Keiller Park Trail Grant. Work will begin soon as we have been given the go ahead to start.
- He anticipates that the animal shelter will be complete within two weeks. The last major upgrade is venting for the water coolers. When the project is complete, we will have a ribbon-cutting ceremony.
- We had the ribbon cutting ceremony for Gonzales Park which went very well. Unfortunately, there were
  people who would have liked to attend, but were unaware of the event. Soltis apologized that the event was
  not better publicized.
- The next Council meeting will be cancelled due to Soltis attending the ACMA conference.
