

RESOLUTION NO. 2010-53

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA [“CITY”] FOR THE PURPOSE OF APPROVING AND ADOPTING THE DESIGNATION OF ALTERNATE LOCATIONS FOR REGULAR, SPECIAL COUNCIL MEETINGS AND WORK SESSIONS AND AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION AND DECLARING AN EMERGENCY TO EXIST.

WHEREAS, the City of Willcox, is authorized and empowered pursuant to the Willcox City Code, Title 1, Chapter 6, Article A, Section 1-6A-1 [Meetings] to designate, in writing, alternate location(s) where Regular, Special Council Meetings and work sessions will be held; and

WHEREAS, the City of Willcox previously designated the locations pursuant to Resolution 2008-15 and needs to designate current locations with new addresses; and

WHEREAS, the Mayor and City Council have determined that approving and adopting a written designation of Council meeting locations as required under the Willcox City Code is in the best interest of the City and its citizens; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of Willcox, Arizona that an emergency be declared to exist to assure timely notice to the public and that this Resolution be effective immediately upon its passage and adoption.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Willcox, Cochise County, Arizona, formally approving and adopting the written designation of locations where Regular, Special meeting and work sessions will be held pursuant to the Willcox City Code, Title 1, Chapter 6, Article A and Section 1-6A-1.

IT IS FURTHER RESOLVED:

1. That this Resolution serves to designate locations where City Council meetings will be held, to authorize the Mayor to execute this Resolution and to direct the City Clerk to perform acts necessary to implement this Resolution and to provide notice to the public by posting this Resolution in the locations where public meeting notices are posted.
