**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA, RATIFYING, APPROVING AND AUTHORIZING THE SUBMISSION OF THE APPLICATION TO THE COCHISE COMMUNITY FOUNDATION [“CCF”] REQUESTING A FUNDING AWARD TO BE USED FOR THE COMMUNITY SKATE PARK PROJECT AND DECLARING AN EMERGENCY TO EXIST.**

**WHEREAS**, the **CITY** is authorized pursuant to A.R.S. ' 9-240, et seq. to exercise control of the property of the corporation and to permit use of municipal property for the purposes of the corporation; and

**WHEREAS**, the **CITY** is vested with all powers of incorporated towns as set forth in Title 9 or other provisions of law relating to cities and towns pursuant to A.R.S. ' 9-499.01, et seq.; and

**WHEREAS**, the **CITY** and the **SKATE PARK COMMITTEE** (“SPC”) have had an on-going working relationship for the development of a Community Skate Park to serve the Youth of the Willcox Community; and

**WHEREAS**, the Mayor and Council is committed to pursue various funding sources to assist in the development of the Community Skate Park; and

**WHEREAS**, City staff seek Mayor and Council ratification and approval for the submitted application to the **CCF** to request funding in the amount not to exceed \$5,000.00; and

**WHEREAS**, the Mayor and Council of the City of Willcox have determined that it is in the best interest of the City and its citizens to ratify and approve the submitted application to the **CCF**; and

**WHEREAS**, the Mayor and Council desire to have this item presented at its July 18<sup>th</sup>, 2011 Council Meeting; and

**WHEREAS**, it is necessary for the preservation of the peace, health, and safety of the City of Willcox, Cochise County, Arizona, that an emergency be declared to exist to assure approval and ratification of the submitted application, and that this Resolution be effective immediately upon its passage and adoption.

**THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Willcox, Cochise County, Arizona, that the City hereby formally ratifies and approves the submitted application to the **CCF**.

**BE IT FURTHER RESOLVED** by the Mayor and Council that, due to an existing emergency declared herein, the immediate effectiveness of this Resolution is necessary to preserve the peace, health, and safety of the City of Willcox, Cochise County, Arizona, and this Resolution shall therefore be effective upon its passage and adoption.
