RESOLUTION 2019-04

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WILLCOX, ARIZONA, ADOPTING A **NOTICE OF INTENTION TO MODIFY WATER AND GAS SERVICE FEES**, DECLARING AS A PUBLIC RECORD OUR SUPPORTING DATA REPORT ENTITLED THE **“CITY OF WILLCOX 2019 WATER AND GAS SERVICE FEE MODIFICATION, DATED APRIL 4, 2019”**, AND SETTING **JUNE 6, 2019**, AS THE DATE FOR PUBLIC HEARING ON THE PROPOSED SERVICE FEE MODIFICATION.

WHEREAS, the City of Willcox has the requisite statutory authority to operate utility services pursuant to the provisions of Arizona Revised Statutes §9-511, et. seq., and such operation requires utility rates and fees generate sufficient revenue to equal the cost of providing service; and,

WHEREAS, presently costs associated with turning on and turning off water and gas services in effect are insufficient to satisfy the requirement of generating sufficient revenue to restore the respective Enterprise Funds; and,

WHEREAS, the Mayor and City Council, when considering increases to any rate or rate component, fee or service charge for utility services, shall adopt a Notice of Intention complying with the provisions of A.R.S. §9-511.01; and,

WHEREAS, in accordance with A.R.S. §9-511.01, the City has prepared the **“City of Willcox 2019 Water and Gas Service Fee Modification” dated April 4, 2019**.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL as follows:


1. This Resolution shall serve as a written **Notice of Intention** to the public that the City of Willcox intends to modify water and gas service turn on and turn off fees; and,
2. The written report entitled **“City of Willcox 2019 Water and Gas Service Fee Modification” dated April 4, 2019**, is hereby declared a public document and three (3) copies of such shall be filed in the Office of City Clerk on **April 5, 2019**, and shall be available to the public for inspection; and,
3. A public hearing on the proposed fee increase shall be held during the regular **City Council Meeting at 6:30 p.m. on June 6, 2019**, at the City Council Chambers located at 300 W. Rex Allen Drive, Willcox, Arizona.
